

Remuneration: This is an unpaid, voluntary role but travel expenses can be claimed.

Community First works tirelessly to help people overcome challenges in their lives and we are passionate about brighter futures for the diverse range of people who live in the communities we serve. We support young people through our national awardwinning 'youth arm' Youth Action Wiltshire, including Youth Action Wiltshire Young Carers Service, Splash, Project Inspire and youth club support. Many of our activities for young people take place at our dedicated outdoor education centres at Oxenwood and Linkenholt.

As the managing partner for the Building Bridges Programmes in Swindon and Wiltshire, Community First is leading a partnership of organisations, who are working together to help people overcome their barriers to employment and education. The programmes are funded by the UK Shared Prosperity Fund and The National Lottery Community Fund.

We also offer support for unpaid Carers (including Parent Carers and Young Adult Carers) through the Carers Together Wiltshire partnership which is led by Age UK Wiltshire.



The Role

We're looking for a Chair with vision and a passion for our communities in Wiltshire and Swindon who will lead the Board in the next stage of our strategic development.

We have a strong and supportive Board with extensive experience across a wide range of sectors both business and voluntary. The wide range of services we offer provides a significant opportunity for a dynamic individual to develop their own and the Board's skills sets as we continue to grow and evolve.

The Chair

The Chair is a trustee with a specific role on the Board. The Chair is elected or appointed to this role annually. The role of the Chair is to lead meetings of the Trustee Board.

Additional roles of the chair include:

- Supporting the Chief Executive and acting as a channel of communication between Board and staff
- Acting as a figurehead and advocate for the charity (for example, representing it at functions, meetings or in the press).
- ✓ Leading on the development of the Board and making sure that its decisions are carried out.
- ✓ Taking urgent action (but not decision-making unless authorised) between Board meetings when it isn't possible or practical to hold a meeting.
- Undertaking the annual review of the Chief Executive.
- Chairing the Annual General Meeting.

In addition to the specific responsibilities of the Chair mentioned above, as a Trustee the Chair also has the same responsibilities as other Trustees, namely:


- To ensure we comply with our governing document, charity law, company law and any other relevant legislation or regulations.
- ✓ To ensure we pursue the objectives outlined in our governing documents.
- ✓ To ensure that we apply our resources only in pursuance of our objectives and do not expend funds on activities which are not included, no matter how worthwhile or charitable these objectives may be.
- ✓ To contribute actively to the Board of Trustees' role in supporting the CEO and Leadership team to set the strategic direction, agree overall policy, defining goals and monitoring targets.
- To monitor and evaluate our performance against agreed objectives.
- To safeguard and uphold the good name and values of Community First.
- ✓ To ensure the effective and efficient administration of our charity and to ensure financial stability.
- ✓ To protect the property of our charity and to ensure proper investment of funds.
- To appoint a Chief Executive Officer and monitor performance and reward.



Chair: Person Specification

Essential

- ✓ Able to run meetings effectively and on time.
- ✓ Have the necessary time available to read papers, attend planning meetings outside of the Board.
- ✓ Have a positive relationship with the CEO and Leadership Team fostering an environment of mutual respect, communication and trust.
- Able to form supportive, productive, inclusive relationships with other Board members, the CEO and the Leadership Team.
- ✓ Have a passion for and advocate for the activities across the whole organisation.
- ✓ Time and motivation to respond in a timely manner to communications, approving minutes etc.
- ✓ Appointing the Vice-Chair.





Terms of Appointment

Appointment Length

Joining a new Board can be an exciting experience but can also be daunting. We are keen to ensure that this experience is as easy as possible. Trustees are recruited for a 3 year term with the Chair as an officer of the Company being approved on an annual basis at the AGM. All new Trustees are initially co-opted prior to being appointed formally to the Board at the AGM in October.

Time commitment

The Chair is expected to Chair the 6 Board meetings held annually in addition to the Annual General Meeting (AGM) which is usually held in October. In addition, The Chair will need to set aside time to have regular meetings with the CEO and Chairs of the two sub-committees.

Payments to Trustees

This is an unpaid, voluntary role. All Trustees may claim expenses for travel, childcare while at Board meetings or support needed due to a disability.

Interview Process

Interviews will take place at the Community First office in Devizes or if this is not possible, by video call. We intend to interview prospective candidates in November 2025.

The interview process will involve a panel consisting of a minimum of 3 existing Trustees and the CEO.

Candidates will be expected to provide a presentation

of their approach to leadership and their perspective on the key areas of focus for their period in office.


Following the interview, the interview panel will make a recommendation to the Board for final approval on the most suitable candidate with supporting rationale for their decision.
